- 4. Disclose any criminal convictions. Any criminal record will be reviewed regardless of how long ago it occurred and will be considered when deciding an applicant's eligibility.
- 5. Provide accurate and complete information on the *El Paso County Combined Court Volunteer Application*.
- 6. All volunteers are required to submit to a routine background investigation, including a criminal history check.
- 7. Complete an interview with the Volunteer Coordinator.

#### INSTRUCTIONS AND INFORMATION

- 1. Print or type your application clearly.
- 2. Please use blue or black ink when filling out this application.
- 3. Answer all questions in its entirety; DO NOT leave any question blank. If a question does not apply to you, you may write "not applicable" or "N/A" on the line.
- 4. The submitted 'El Paso County Combined Court Volunteer Application' must be signed and dated by the applicant. An unsigned application may be rejected.
- 5. Please note: there is no appeal process for disqualification from the Volunteer Program.
