Changes to add For Cause evictions from the new law that went live April 19th.

Note that the title of JDF 139 B for Mobile Home Evictions will also change to "Notice to Terminate Tenancy" later this Summer.

### c) Forms Process from Legislation

The Forms Team has one Form Editor. That editor:

- 1) Is notified of possible changes from pending legislation.
- 2) Conducts legal research on the bill and formulates updates needed.
- 3) Edits/creates the form.
- 4) Sends it for internal review and incorporates any edits.
- 5) Sends it to the Supreme Court for review and incorporates any edits.
- 6) Remediates and publishes the form.
- 7) Sends it to the Translation Team for translated version updates.
- 8) Formats, remediates, and then publishes the new translated version.

Steps 5, 6, and 8 are new this year. This new process will take more time to publish forms than in the past. We aim to update the English version within 4-6 weeks after the legislation goes live. The translated version can take up to six months.
