ORDER OF APPOINTMENT

Appointment of Office of Dispute Resolution Advisory Committee Members

The Order entered November 17, 2005, regarding the Office of Dispute Resolution Advisory Committee is hereby amended to read as follows:

WHEREAS, it is important to promote a statewide and system-wide perspective regarding alternative dispute resolution in Colorado and continually to improve the planning, administration and integration of alternative dispute resolution programs statewide as well as within the Judicial Branch,

NOW THEREFORE, the Office of Dispute Resolution Advisory Committee serves the following purposes:

- To review and make recommendations concerning the creation, expansion, administration and evaluation of dispute resolution programs throughout the state.
- To review and make recommendations concerning alternative dispute resolution policies throughout the state.
- To advise the Director of the Office of Dispute Resolution concerning policies, procedures, and strategies for improving service delivery of Office of Dispute Resolution programs throughout the state.
- To review and make recommendations regarding fees for services offered by the Office of Dispute Resolution.

General Provisions

The Committee shall meet at least two times per year.

All members shall serve three year terms. Terms may be repeated without limit. The Committee may establish subcommittees and adopt rules of procedures as deemed necessary to govern activities. Such rules shall be published on the Court's website.

Membership

The membership of the Office of Dispute Resolution Advisory Committee shall be appointed by the Chief Justice of the Supreme Court of Colorado.
