

## 18th Judicial District CFI Eligibility Roster

The 18th Judicial District is not certifying or recommending any professional by inclusion in this roster. Inclusion in this roster only indicates that the professional has submitted a completed affidavit to SCAO and that the professional has successfully passed a criminal background check with the Colorado Bureau of Investigation through processes and guidelines established by SCAO. Inclusion in this roster only indicates eligibility for consideration of appointment by a judicial district or the Office of the Child's Representative. Judicial districts and the Office of the Child's Representative determine final eligibility for appointment of any Child and Family Investigator. A party considering requesting appointment of a Child and Family Investigator should conduct an independent investigation of the qualifications of a professional. Being included on the eligibility roster should not create an expectation of appointment by the Court.
