b) Word Format Retiring

You may notice not all forms are available in Word format. Judicial is transitioning from designing the base form in Word to a publication program (like Adobe InDesign).

- Given accessibility requirements, the WORD format alone doesn't meet the Judicial Department's statutory obligations.
- Converting from Word to PDF can take many hours to make the document accessible.
- A change to publication software will require far less time to update forms and ensure they meet accessibility standards.
- As a form is remediated, its Word version is removed from the website (exception proposed orders).
