3. **Opinions on Domestic Violence and Abuse** For the PRE to give opinions on domestic violence and child abuse in the report or at hearing, they must meet the qualifications under C.R.S. § 14-10-127.5. The Court finds: a) The PRE meets those qualifications. b) The parties all agree (*stipulate*) the PRE meets those qualifications. c) The PRE does not meet those qualifications. They can complete an evaluation and report and must include data and facts that may indicate domestic violence and child abuse if either is alleged.
