Administrative:

The June 2017 minutes were approved (Eileen Kinney motion, Joe Thome second).

The Board decided to nominate Deb Duran to continue as Co-Chair, pending her agreement to continue. This will be addressed at the August meeting.

The draft Funding Application was distributed and discussed. Marcy will provide an electronic copy to board members requesting feedback before the August Board meeting.

CAM Evaluation Presentation:

Guests Glenn Tapia, Erin Crites and Chrystal Owin presented the results of the Colorado Assessment Match (CAM) study that was funded by the Board, including a brief history of relevant statutes and the Standardized Offender Assessment (SOA) process. This study found minimal consistency in treatment matching between the CAM decision making tool and clinical judgment when all seven treatment levels were assessed. However, consistency improved when the seven treatment levels were collapsed into three broader categories. The results of the study will be utilized to inform policy development amongst those state agencies required by statute to implement the SOA process. The Board was thanked for supporting this process and funding the CAM evaluation.

CCJC Conference Update:

The CCJC planning committee is still processing the information from the conference evaluations from the 2017 conference. The plenary sessions all received a high level of positive feedback. There was positive feedback about the conference overall. The Board committed to continue at least the same level of funding to future conferences (2018, 2019 and 2020).

ACA Subcommittee:

The Board decided to wait to ask the ACA subcommittee to start again. It was suggested that the CTB staff get in touch with the Criminal Justice Liaisons within each Behavioral Health Organization as a next step to stay current with the system changes at the state level in healthcare.
