

**CFI/PRE COVER PAGE FOR HB23-1178 DOMESTIC VIOLENCE AND CHILD ABUSE  
TRAINING AFFIDAVIT**

\*you must turn in all 20 hours of training at the same time with one cover page\*

Pursuant to 14-10-116.5, as of January 1, 2024, initial and ongoing training must include, at a minimum:

- (I) Ten initial hours of training on domestic violence, including coercive control, and its traumatic effects; and
- (II) Ten initial hours of training on child abuse and child sexual abuse and its traumatic effects; and
- (III) Fifteen subsequent hours of training every five years on domestic violence, including coercive control, child abuse, and child sexual abuse, and the traumatic effects on children, adults and families.

Pursuant to 14-10-127.5, the domestic violence and child abuse training referenced above must focus on the following topics:

- (I) Child sexual abuse;
- (II) Physical abuse;
- (III) Emotional abuse;
- (IV) Coercive control;
- (V) Implicit and explicit bias, including biases relating to parties with disabilities;
- (VI) Trauma;
- (VII) Long-term and short-term impacts of domestic violence and child abuse on children; and
- (VIII) Victim and perpetrator behavioral patterns and relationship dynamics within the cycle of violence.

A professional trainer shall conduct the required training. The professional trainer shall have substantial experience in assisting survivors of domestic violence or child abuse. A professional trainer may include a professional representing a victim service provider. (See §14-10-127.5, C.R.S.)

“Victim service provider” means a nonprofit, nongovernmental or tribal organization or rape crisis center, including of a state or tribal nation, that is subject to section 13-90-107 (1)(k)(i) and assists or advocates for domestic violence, dating violence, sexual assault, or stalking victims, including domestic violence shelters, faith-based organizations, and other

organizations with a documented history of effective work concerning domestic violence, dating violence, sexual assault, or stalking. (See §14-10-127.5, C.R.S.)

The professional trainer shall rely on evidence-based and peer-reviewed research conducted by recognized experts or research conducted in the field by recognized domestic violence victim advocates that focuses on the types of abuse described in §14-10-127.5(5)(b) and shall not include theories, concepts, or belief systems in the required training that are not supported by evidence-based and peer-reviewed research or research conducted in the field by recognized domestic violence victim advocates. (See §14-10-127.5, C.R.S.)
