II. Approval of Minutes

The Committee approved the October19, 2015 minutes as submitted.

III. Announcements from the Chair

Chief Judge Loeb announced that:

• Rule 3.4 has been posted for public comment and comments were due April 6, 2016;

- New member Dan Domenico was introduced and welcomed; and
- The committee still needs to address the supreme court rules and Rules 8 and 10 that were assigned to subcommittees.

IV. New Business: Proposed drafts of Colorado Appellate Rules

The following revisions were discussed and adopted by the committee:

- Rule 35; subsection (a) was redrafted because it contained many trial court functions, and the committee divided it into two additional subsections: (b) Equally Divided Supreme Court and (c) Harmless Error that passed 6 to 2; all other revisions passed unanimously;
- Rule 39.5 has been renumbered to 39.1 to be consistent with other appellate rules; a subcommittee was formed to address the issue of when appellate fees are recoverable and the rule is tabled until the next meeting;
- Rule 40; new section (c) addresses when a petition for rehearing can't be filed; all amendments passed unanimously;
- Rule 41; the contents of Rule 41.1 are added to subsections (b) and (e); separate sections for staying and issuing a mandate, when the mandate becomes effective, and recalling the mandate were added; all amendments passed unanimously;
- Rule 41.1; the contents of the rule were added to Rule 41 and the rule has been deleted; and
- Rule 42; clarifies when an appellate court must dismiss an appeal or other appellate proceeding, versus when an appellate court may dismiss an appeal or other appellate proceeding; all amendments passed unanimously.

A transmittal letter will be prepared and rules will be submitted to the supreme court.
