III. Announcements from the Chair

Chief Judge Loeb began by discussing the following:

- A new member, Judge Todd Plewe, had been appointed to the committee;
- The post-opinion rules from the last meeting had been submitted to the supreme court; and

• The court of appeals discussed Rule 35, to include access to non-published opinions and cite-ability. The court will discuss Rule 35 again in early December.

IV. New Business: Proposed drafts to Colorado Appellate Rule 3.4

Chief Judge Loeb introduced the Rule 3.4 subcommittee: Judge Taubman, Judge Furman, Judge Ashby, and motions attorney David Dean. The following revisions were discussed and adopted unanimously by the committee:

- Timely filing of the notice of appeal by counsel or self-represented litigant;
- Preparation of transcripts instead of filing the designation of record;
- Opening brief filed 21 days after the record is filed;
- Answer brief filed 21 days of the filing of the opening brief;
- Citation to record showing ICWA compliance;
- Amending forms and referring to forms by JDF number; and
- Other changes for organization and efficiency.

A transmittal letter will be prepared and Rule 3.4 will be submitted to the supreme court. Chief Judge Loeb thanked committee and subcommittee for their work on this proposal.
