Whether *Flowers v. Mississippi*, 139 S. Ct. 2228, 2249 (2019) – which allows courts to compare general similarities between prospective jurors for purposes of a *Batson* analysis – impliedly overruled this court’s contrary suggestion in *People v. Beauvais*, 2017 CO 34, paragraph 56, 393 P.3d 509, 524, such that the division erred in following *Beauvais* to affirm the trial court’s *Batson* ruling in this case.
