The US Environmental Protection Agency ("EPA") has had the area generally closed due to its remediation efforts at the Gold King Mine. The well permit that Applicant had received in 2015 expired without the ability to construct the well. As a result, the well had not been drilled. b. Applicant has hired Ken Schaaf to apply for a new well permit, which application is on file at the office of the State Engineer. Upon issuance of a new well permit, the Applicant intends to drill and complete the well. Therefore, Applicant hereby requests that the conditional right be continued.
