Second Motion to Amend Criminal Complaint and Information (P-005)	

On March 24, 2021 the People filed the original Criminal Complaint and Information against Ahmad Al Aliwi (the "Defendant"). On April 21, 2021, the People filed a Motion to Amend Criminal Complaint and Information (the "Motion"). The Court granted the Motion on April 23, 2021. As the investigation into the above captioned case has continued, the People have determined that additional crimes and sentence enhancers should be charged in this matter. Therefore, the People are again moving to amend the Complaint and Information, specifically by amending certain current pending counts and adding several additional counts, as detailed below.

Colo. R. Crim. P. 7(e) permits the amendment of a complaint or information as to form or substance at any time prior to trial. Whether to permit an amendment is left to the sound discretion of the trial court. *See People v. Butler*, 224 P.3d 380 (Colo. App. 2009); *see also People v. Wright*, 678 P.2d 1072 (Colo. App. 1984). However, reviewing courts have favored a liberal application of Rule 7(e). *See Cervantes v. People*, 715 P.2d 783 (Colo. 1986); *see also People v. Al-Yousif*, 206 P.3d 824 (Colo. App. 2006).

Defendant is not prejudiced by the amended and added counts proposed by the People in this motion as the evidence supporting the counts is contained in the discovery already provided to Defendant in the above captioned case. The factual basis for the added charges originates from the same incident and events previously disclosed to Defendant in discovery. Additionally, this case is in its infancy. The Court has yet to schedule a preliminary hearing in this matter.

The People move to amend or add Count 11 through Count 115 to read as follows (Count 1 through Count 10 remain unchanged from the Motion filed on April 21, 2021):
