UPDATE: Includes information on a second vacancy 18th Judicial District announces District Court vacancies Commission sets date to select nominees

The Eighteenth Judicial District Nominating Commission will meet Sept. 1, 2022, at the Arapahoe County Justice Center (7325 S. Potomac St., Centennial, CO 80112) to interview and select nominees for appointment by the governor to two District Court judgeships for the Eighteenth Judicial District (Arapahoe, Douglas, Elbert and Lincoln counties). The vacancies will be created by the retirements of the Honorable Frederick T. Martinez and the Honorable Elizabeth Weishaupl. Both vacancies will occur on Jan. 10, 2023.

To be eligible, the applicant must be a qualified elector of the Eighteenth Judicial District at the time of investiture and must have been admitted to the practice of law in Colorado for five years. The current annual salary for these positions is \$183,816. The initial term of office of a district judge is a provisional term of two years; thereafter, the incumbent district judge, if approved by the voters, has a term of six years.

The completed application must be e-mailed to the address listed in the instructions below no later than 4 p.m. on Aug. 12, 2022. Late applications will not be considered. Any person wishing to suggest a candidate to fill a vacancy may do so by letter to be submitted to any member of the nominating commission, with a copy to the ex officio chair, no later than 4 p.m. on Aug. 5, 2022.

Instructions

- 1. The application form for a Colorado state court judgeship can be found on the Judicial Branch website at http://www.courts.state.co.us/Careers/Judge.cfm. Please be complete and thorough in answering the questions; and, if an answer to any question requires more space than provided, attach a separate sheet of paper for each question. Do not change the margins or font size on the application.
- 2. Your application materials should be prepared in the following manner:

The application should be saved as a PDF file (preferably in text searchable format. The electronic application does not need to contain a signature. If your application materials include multiple documents (i.e., cover letter, personal statement, reference letters) these documents should be combined into one single PDF document with the reference letters attached last.

You must submit the names of not fewer than three nor more than five individuals from whom you are requesting a letter of reference. It is preferred that reference letters are included with your application submission. If they are submitted directly by the author, they should be submitted by email as described below in paragraph 3. It is your responsibility to ensure that all letters of reference are submitted by the filing deadline listed in paragraph 4.

3. Your application materials compiled as outlined above should be sent via email with **your name and 18**th **JD Arapahoe County in the subject line** with your materials attached as outlined above no later than 4 p.m. on **August 12, 2022** to the following email address:
