Custody Guide (Parental Responsibility Cases)

(File to set Child Support, Decision-Making, and a Parenting Time Schedule)

Who is this for?

Parents who are not married or in a civil union.

With your input, the court will:

- Set the amount for child support.
- Lay out how important life decisions will be made for the children.
- Create a parenting time schedule.

To file, the children must have lived in Colorado for the last 182 days.

Who can start the case?

Either parent can start the case.

Can a non-parent participate?



Yes, if:

- 1) You've had parental responsibility for at least 182 days.
- And, the case is started within 182 days since you lost the parental responsibility.

Or, at this time, neither parent has physical care of the child/ren.

Where do I File?

File in the district court in the county where the children live.

The information on this page is legal information.

For legal advice, talk to a lawyer.

Can we get help to solve our disagreements?

The State Office of Dispute Resolution helps parents with unresolved legal issues. [http://www.coloradoODR.org]

What if the other parent is not the "legal" father?

You will need to resolve who the legal father is before starting this type of case.

See JDF 1500 - Paternity Instructions.

Will an investigator or lawyer be assigned?

Maybe. The court can assign an investigator to get more information about the family.

Or, the court can appoint a lawyer for the child if it believes they need one.

The parents do not get a court appointed lawyer.

Do I have to have a lawyer?



You do not *have to* have a lawyer, but you must follow the same rules and procedures that lawyers follow. You may contact a lawyer at any time.

Will I have to take a parenting class?

Yes. Both parents have to take a parenting class. The court will give you more information on class times and locations.

Fill out court forms



The process is simpler if you and the other parent sign the petition together.

Fill out these forms:

JDF 1000 Case Information Sheet.

· JDF 1031 Petition.

• JDF 1032 Summons. (skip if you sign the petition together)

Keep a copy of all forms you file with the court for your records.

(2) File Your Forms

- File online at www.jbits.courts.state.co.us/efiling.
- Or, submit your completed forms with the Court Clerk in the county where you or your spouse lives.



- Pay the filing fee.
- If you cannot afford the fee, also file:
 - o JDF 205 Motion, and
 - JDF 206 Order (Just the caption)
- You will be scheduled for an Initial Status Conference within 42 days of your filing.
- Procedural Orders will be given to you or mailed depending on the local court process.

(3) Service

- Skip this step if you sign the petition together.
- Review JDF 1099 for how to serve the other parent.

(4) Response

- Skip this step if you sign the petition together.
- Respondent does form JDF 1035 Response.
- See Step 2 to file.
- eServe or mail a copy to the Petitioner.

(5) Complete and File these forms:

Deadline Warning!

Within **42 days** after filing or receiving the Petition, each parent must file:

JDF 1111 Sworn Financial Statement

JDF 1104 Certificate of Compliance

Other Forms to File:

JDF 1113 Parenting Plan
 Parties submit one document signed together. If you cannot agree, mediation may be ordered.
