<p>PETITION FOR REVIEW OF FINAL ACTION OF BALLOT TITLE SETTING BOARD CONCERNING PROPOSED INITIATIVE 2023-2024 #284 (“TRANSPORTATION FEES”)</p>	

Jessica Goad, registered elector of the State of Colorado, (“Petitioner”), through undersigned counsel, respectfully petitions this Court pursuant to C.R.S. § 1-40-107(2), to review the actions of the Title Setting Board with respect to the title, ballot title, and submission clause set for Initiative #284.

STATEMENT OF THE CASE

A. Procedural History of Proposed Initiative #284.

Michele Haedrich and Steven Ward (hereafter “Proponents”) proposed Initiative #284. A review and comment hearing was held before representatives of the Offices of Legislative Council and Legislative Legal Services on April 3, 2024.

A Title Board hearing was held on April 17, 2024, at which time the Title Board found that Initiative #284 contained a single subject and set a title. On April 24, 2024, Petitioner Jessica Goad filed a Motion for Rehearing, alleging that Initiative #284 contained multiple subjects, contrary to Colo. Const. art. V, sec. 1(5.5), and that the title set by the Title Board was misleading. The Title Board held a rehearing on April 25, 2024, at which time the Title Board granted the Motion for Rehearing only to the extent that it made some changes to the title.

B. Jurisdiction

Petitioner is entitled to review before the Colorado Supreme Court pursuant

to C.R.S. § 1-40-107(2). Petitioner timely filed this Petition for Review within seven days from the date of the hearing on the Motion for Rehearing. C.R.S. § 1-40-107(2).

As required by C.R.S. § 1-40-107(2), attached to this Petition for Review are certified copies of: (1) the draft, amended, final, second amended, and second final version of the initiative filed by the Proponents; (2) the original ballot title set for this measure; (3) the Motions for Rehearing filed by the Petitioner and by the Proponents; and (4) the ruling on the Motions for Rehearing. Petitioner believes that the Title Board erred in denying her Motion for Rehearing by finding the measure contains a single subject, and by setting a misleading title. The matter is properly before this Court.

GROUND FOR APPEAL

The issues to be addressed in this appeal are whether the Title Board erred in finding that Initiative #284 contains a single subject, and whether the title as set by the Title Board is misleading.

PRAYER FOR RELIEF

Petitioners respectfully request that, after consideration of the parties' briefs, this Court determine that Initiative #284 contains a single subject and direct the Title Board to set a title.
