Pursuant to C.R.S. 37-92-302, as amended, you are notified that the following is a resume of all applications filed in the Water Court during the month of January 2021.

The names, address of applicant, source of water, description of water right or conditional water right involved, and description of the ruling sought are as follows: There has been filed in this proceeding a claim or claims which may affect in priority any water right claimed or heretofore adjudicated within this division and owners of affected rights must appear to object and protest as provided in the Water Right Determination and Administration Act of 1969, or be forever barred.

CASE NO. 2020CW57 AMENDED; Applicant: SJS Property, c/o Seth Schwartz, PO Box 6762, West Palm Beach, FL 33405. Amended Application for Underground Water Right, Storage Right, Change Water Right, and Approval of Plan for Augmentation. The amended application increases the amount of the change in Water Right for the Stewart Ditch from 0.0015 cfs to 0.0086 cfs to match the standard duty of water of 1 cfs to 40 acres for irrigation in the original decree. The irrigated acreage dry-up of 0.344 acres corresponds to the cfs amount of 0.0086 cfs. APPLICATION FOR UNDERGROUND WATER RIGHT: SJS Well – SW1/4NW1/4 of Section 28, T13S, R91W, 6th P.M. Easting 277240, Northing 4308206, Zone 13. Source: North Fork of the Gunnison River. Appropriation Date: 9/20/2016. Amount claimed: 15 gpm (0.0334) cfs Absolute for domestic, Conditional for commercial and irrigation. APPLICATION FOR CHANGE IN WATER RIGHT: Stewart Ditch - Location of structure: The Stewart Ditch headgate is located in the NW1/4NW1/4 of Section 28, T13S, R91W, 6th P.M. This applicant does not propose any modification of the existing diversion structure in any way. Original Decree: The applicant owns 35.2 shares in the Stewart Ditch, transferred from Tropic Ditch rights for priorities 1, 27 and 40. According to the Quit Claim deed for the property (attached), the applicant has ownership (like interest) in each of the priorities listed below. All three priorities have an Adjudication Date of 4/12/1901 for irrigation uses. The Stewart/Tropic Ditch has a right with Priority 1 for 1.25 cfs with an Appropriation Date of 6/1/1882; a right with Priority 27 for 4.73 cfs with an Appropriation Date of 12/27/1892, and a right with Priority 40 for 1.06 cfs with an Appropriation date of 4/1/1901. The Stewart Ditch, not associated with the Tropic Ditch rights, also has flood rights for 70.925 cfs with priorities of 3IB, A24, A122 and J158, but those rights do not pertain to this case. The Stewart/Tropic Ditch rights, is apportioned into 192 shares for 7.04 cfs, making each share worth 0.0367 cfs per share for all three priorities. Since the senior 1.25 cfs portion of a share is 0.0065 cfs/share, the applicant seeks to change 1.32 share of their total of 35.2 shares. Decreed source: North Fork of the Gunnison River. Amount proposed to be changed: 0.0086 cfs Absolute; of Priority 1, Adjudication date of April 12, 1901 and Appropriation date of 6/1/1882. Decreed use: Irrigation, Domestic, Commercial, and Augmentation. Detailed description of proposed change: Applicant desires to change 0.0086 cfs of this right to domestic, commercial, irrigation, and augmentation uses for the protection of consumptive uses from the SJS Well. In the case of a river call, the 0.0086 cfs of the No. 1 priority will be bypassed back into the river at the Stewart Ditch headgate.

Attached Tables 1 through 4 shows the amount that must be changed to compensate for the consumptive uses and the means to replace them. APPLICATION FOR APPROVAL OF PLAN FOR AUGMENTATION: SJS Well - Location of structure: Described above. Water rights to be used for augmentation: 0.0086 cfs of the Stewart Ditch as described above. Appropriation Date: 2/23/2018. Complete statement of plan for augmentation: Applicant seeks to replace out-of-priority depletions associated with consumptive uses from SJS Well. The applicant seeks to augment the following uses in the SJS Well: Domestic uses for a total of 6 single family dwellings. The use rate is 350 gallons per dwelling per day. Domestic uses for 8 seasonal cabins without dishwasher or laundry facilities. The use rate is 150 gallons per cabin per day. Commercial use in a single bathroom in the commercial building at 50 gallons per day. Commercial use for a 4000 square foot bakery at the use rate of 116.4 gallons per day per 1000 square feet of space. This bakery does not serve customers at the bakery, they are strictly a source for baked goods. Commercial indoor irrigation for the starting of Cannabis plants for the months of March through July. The plants are then moved to greenhouses for summer growth. The attached Tables 1 through 4 show the current and future uses at the well. There is no municipal wastewater system in this area, so each house and commercial building will have their own septic system, with septic tank and leach field. The cabin might be joined together into a single septic system or joined with another system. The CU for water in a septic system is 10%.

To obtain CU credits from the Stewart Ditch, the applicant is drying up 1.1 acres of land that was historically irrigated by the ditch. These areas are shown in attached Map 1. The applicant will continue to use ditch water to irrigate 11 different greenhouses in the general area of the dry-up, 4 that are 92 x 46 feet in dimension, and 7 that are sized 25 x 100 feet. The square footage from the irrigated greenhouses, 0.756 acres, is subtracted from the 1.1 acres of dry-up for a total dry-up of 0.344 acres. The consumptive use from this 0.344 acres of dry-up is then changed to domestic, commercial, irrigation and augmentation purposes to replace the depletions from the well. The resulting credits shown in Table 3 are enough to replace the well CU in the months of May through October. The river calls on the North Fork usually occurs in the months of June through October. The No. 1 right in the Stewart Ditch is always in priority. The only non-irrigation season call that could occur on the North Fork of the Gunnison River is from the Redlands Canal. The applicant plans to purchase water from Blue Mesa Reservoir to replace the CU on the months of November through April. The applicant will obtain a contract from the USBR for 0.5 af of water, the minimum amount, prior the decree being signed. The detailed accounting of all CU calculations is contained in the 12/30/2020 Engineering Report by WRS, LLC. The applicant intends to amend the well permit for SJS Well once the decree is signed.
