Date of original and all relevant subsequent decrees: The first 3 Paonia Ditch decrees dated April 12,1901 (case CA0228) and the 4th Paonia Ditch decree dated May 28, 1937 (case CA2563) and the Wade and Hightower ditch decree dated April 12,1901 (also decreed along with the first 3 Paonia Ditch decrees in case CA0228). The first 3 Paonia Ditch decrees adjudicated under CA0228 and the 4<sup>th</sup> Paonia Ditch decree adjudicated under CA2563. The Wade and Hightower decree was originally adjudicated under CA0228 (along with the first 3 Paonia Ditch decrees) and granted a Change in Point of Diversion adjudicated by Civil Action Number 4850. The first 3 Paonia Ditch decrees in Delta District Court -Delta, the 4th Paonia Ditch decree in Seventh Judicial District Court- Delta and the Wade and Hightower Ditch decree in Delta District Court - Delta. The grant of change in Point of Diversion for the Wade and Hightower decree was issued by the District Court in and for the County of Delta. Legal description of structure as described in most recent decree that adjudicated the location: 1. The most recent decree that described the Paonia Ditch diversion (CA4850) located it "on the left bank of the North Fork of the Gunnison River at a point whence the Northwest corner of the NE1/4NE1/4, Section 6, Township 14 South, Range 91 West of the 6th Principal Meridian bears North 74° East 470 feet." This decreed location is approximately 3.800 feet downstream of the current location (see map). 2. The most recent decree that described the Wade and Hightower diversion (CA4850, which was a change in location for the Wade and Hightower) located it "at a point on the North Fork of the Gunnison River, 175 feet South of a point 36 rods East of the Northeast corner of the NW1/4 of Section 6, in Township 14 South of Range 91 West of the 6th Principal Meridian." This decreed location is close (app. 175 feet) to the current location. 3. In case CA4850 the Wade & Hightower Ditch Company (which also owned 3 cfs of the Paonia

Ditch priority H37) was given the right to divert water from Minnesota Creek as an alternate point of diversion. This decreed location is accurate and is still being used by both ditch companies today.

Complete Statement of Change: Complete statement of change: This request is intended to clarify the location of the combined point of diversion that is currently being used by both the Paonia Ditch and the Wade and Hightower Ditch. The current combined point of diversion has been in use since at least 1956 and no new diversions are being requested. No changes in types or places of use are being requested. This request is also intended to clarify that the alternate point of diversion out of Minnesota Creek, which was granted in case CA4850 to the Wade and Hightower Ditch Company, can also be used to help satisfy any or all of the Paonia Ditch decrees (as has also been the case since at least 1956). Since the original diversions for both ditches were downstream of the confluence of Minnesota Creek with the North Fork, and the current combined diversion is upstream of that confluence, both companies will continue to make use of Minnesota Creek water (via the requested alternate point) during those times when the North Fork is on call, in order to prevent injury to up-stream water right holders. Although most commercial uses of the Roc Creek Ranch property have been postponed due to economic conditions, including but not limited to pandemic-related slowdowns, the property has been used for guided horseback rides and hikes. ii. Following severe flooding in 2013, Applicant regraded irrigated areas to remove debris. iii.
