The People, through District Attorney MICHAEL T. DOUGHERTY, respectfully submit the following response to the Defendant's Motion.

- 1. The People are in agreement C.R.S. 18-1-406(5) requires the Court to provide "a list of prospective jurors who will be subject to call in the trial" at the request of the Defendant. The People believe the Court has previously indicated the parties will be provided with a list of the potential jurors prior to trial. The People have no objection to supplying the parties with the list of potential jurors prior to trial and join in Defendant's request.
- 2. The People are in agreement that pursuant to C.R.S. 18-1-406(6) either party, "may challenge the array on the ground that there has been a material departure from the requirements of the law governing the selection of jurors." It is essential the parties be provided with information about the selection and summons process in order to assess any potential claims. The People believe it is appropriate for the Court to provide information about the process utilized in order to confirm the requirements of C.R.S. 13-71-107 through C.R.S. 13-71-111 were met. The People have no objection to the Court providing the information about the process utilized to the parties.

WHEREFORE, the People have no objection to providing the parties with information about the juror selection and summoning process utilized in the Twentieth Judicial District in this case.
