Amendment of Application Pursuant to C.R.C.P. Rule 15(a)

LAKE COUNTY

Applicant, Parkville Water District, hereby amends its application in this case as a matter of course pursuant to C.R.C.P. Rule 15(a); no responsive pleadings have been filed. Applicant requests that the following amendment be published as required by law, in a form substantially as follows: Applicant, Parkville Water District, amends its application by deleting the following from the original application: "Applicant also claims the right to use such augmentation water in other augmentation plans within or without its boundaries, and to lease or sell such water for use in other augmentation plans, to the extent that the augmentation water so stored is considered to be excess to Applicant's needs in this plan for augmentation. Use of any such 'excess' stored augmentation water will occur only pursuant to a substitute water supply plan approved by the State Engineer, or to a court-approved plan for augmentation." In its place, Applicant inserts the following language: "In this application, Parkville Water District shall limit its augmentation uses of the Canterbury Tunnel (Stevens and Leiter Ditch) consumptive use water to replacement of stream depletions which are reasonably necessary to replace depletions associated with pumping the Canterbury Wells in the event that the Stevens and Leiter Ditch right is out of priority, and storage of consumptive use credits commensurate therewith. Nothing herein shall be construed to waive Applicant's right to use consumptive use credits from its Canterbury Tunnel (Stevens and Leiter Ditch) rights in other plans for augmentation at other locations, pursuant to a substitute water supply plan approved by the State Engineer, or to a court-approved plan for augmentation."
