TAKE NOTICE that you may be affected by the foreclosure of a Deed of Trust on the real property situate in Pueblo County, Colorado, described below.

The Applicant, Twostar, LLC has filed a Motion with this Court, claiming to be the Owner of a Promissory Note in the original principal amount of \$110,400.00 dated January 30, 2015 signed by A&R Properties Group, LLC and a Deed of Trust to the Public Trustee of Pueblo County, Colorado, dated January 30, 2015, signed by A&R Properties Group, LLC and recorded January 30, 2015, under Reception No. 1995400 of the records of Pueblo County.

The Motion claims that Twostar, LLC has the right to foreclose the Deed of Trust because of failure to pay principal and interest when due together with all other payments provided for in the evidence of debt secured by the deed of trust and other violations thereof.

The Motion requests a Court Order authorizing the Public Trustee to sell the real property in Pueblo County, Colorado, described as:

If you dispute the default or other facts claimed by Twostar, LLC to justify this foreclosure, or if you are entitled to protection against this foreclosure under the Servicemembers Civil Relief Act of 2003, as amended, you must make a written response to the Motion, stating under oath the facts upon which you rely and attaching copies of all documents which support your position. This response must be filed with the Clerk of this Court at the Pueblo County District Court, 501 N. Elizabeth., Pueblo, CO 81003 not later than **the 4th day of December 2024 by 8:15 a.m.**, and a copy of the response

must also be mailed or delivered by the same date to Kwitek McMillan, P.C., 601 N. Main Street, Suite 200, Pueblo, CO 81003.

IF NO RESPONSE IS FILED BY THE 4th DAY OF DECEMBER 2024 by 8:15 A.M., THE COURT MAY, WITHOUT ANY HEARING, AUTHORIZE THE FORECLOSURE AND PUBLIC TRUSTEE'S SALE WITHOUT FURTHER NOTICE.

If this case is not filed in a county where your property or a substantial part of your property is located, you have the right to ask the Court to move the case to that county. If you file a response and the Court sets a hearing date, your request to move the case must be filed with the Court at least 7 days before the date of the hearing unless the request was included in your response.
