8. Letters of guardianship will be issued. This emergency guardianship expires on _____ (date not to exceed 60 days from appointment.) The powers and duties of the emergency guardian are as follows:

- To access minor's medical records and information. The emergency guardian is deemed to be the minor's personal representative for all purposes relating to the minor's protected health information, as provided in HIPAA, Section 45 CFR 164.502(g)(2).
- Si aad marin ugu hesho diiwaanada caafimaadka ee ilmaha yar iyo macluumaadka. - To authorize any and all medical and dental care for the health and well-being of the minor. This care includes, but is not limited to, medical and dental exams and tests, x-rays, surgeries, anesthesia, and hospital care.
